TERMS & GENERAL PROGRAM INFORMATION

Payroll Deduction Pledges: All payroll deductions begin January 2022. This may be either one-time or per-pay-period contributions. The total contribution for the year should be written in the **My Total Contribution** box on the other side. Pledge forms must be signed by the donor.

Credit Card Pledges: Employees pledging to make credit or debit card payments within one year in the future. Employees electing credit card payments should visit www.unitedwayabilene.org and click **Give** to execute payment. This is the most secure way for donors to provide credit card information. Pledge forms must be signed by the donor.

Bank Draft Pledges: Employees pledging to make or bank draft (electronic check) payments. These employees must include a voided check with their pledge forms. United Way of Abilene will execute bank drafts as indicated on the pledge form. Pledge forms must be signed by the donor.

Bill Me Pledges: Employees who want United Way to bill the employee directly on a one-time or periodic basis within one year in the future. Pledge forms must be signed by the donor.

Leadership Gifts: A contributor who makes a gift qualifying for status to one of United Way of Abilene's giving designations in any calendar year either as an individual or jointly with spouse will receive recognition in United Way of Abilene publications and social media. Leadership donors may indicate acknowledgment preferences on their pledge forms.

Women United: Women inspiring change through leadership giving. Special events and recognition in United Way publications and social media. Minimum gift of \$500 annually.

Alexis de Tocqueville Society: Ensures that basic and emerging needs are met for our neighbors. To qualify for this leadership level, donors must make a minimum gift of \$10,000 annually. The Alexis de Torqueville Society is the highest level of philanthropy for the United Way Annual Campaign.
