1 MILLION WAYS to MIND the GAP

On October 25, 2021, United Way announced that we surpassed a million dollars of direct relief on behalf of our neighbors. In total, we provided \$1,127,555 in assistance for the February Winter Storm, COVID relief, and the 2019 tornado recovery. Disbursements were provided to landlords, mortgage lenders, and utility companies to keep people in their homes and utilities turned on.

During the most challenging times—two catastrophic events—the COVID-19 pandemic and the February Winter Storm, our city rallied and came to the aid of our neighbors. In 2021, United Way of Abilene made distributions of \$2,248 to complete repairs from the 2019 tornado.

WEATHERING THE STORM - \$191,147

In the midst of a pandemic, the winter storm that hit much of the south in February of 2021 brought our community to a virtual standstill. We lost six of our neighbors; we lost our power and water. Our plumbing froze and hundreds of homes experienced leaks when the water was restored and things began to thaw.



Thanks to Abilene's generosity, we were able to:

- Partner with City Light Ministries to give away \$20,000 in grocery store gift cards to help our neighbors replace staple items that were lost,
- Repair 62 households with plumbing damage with the help of Beltway Park Boots on the Ground ministry,
- Allocate \$40,000 in funds to City Light Ministries to help provide utility aid.

COVID RELIEF - \$934,160

In 2021, United Way of Abilene, in partnership with the City of Abilene, we made over 400 disbursements to landlords, mortgage lenders, and utility companies on behalf of local residents.

Additional allocations were made to Christian Service Center, City Light Ministries, and St. Vincent de Paul to be used for housing, food, and utility assistance.

Betty Hardwick Center, Serenity House, and Salvation Army all received funds to help with housing placement due to COVID-19 exposure.

EMERGENCY FOOD & SHELTER PROGRAM - \$43,288

The Emergency Food and Shelter Program (EFSP) was created to supplement and expand local non-profit agencies' work to help people with economic emergencies.

EFSP funds are used to supplement feeding, sheltering (including transitional sheltering), and rent/mortgage and non-disaster related utility assistance efforts only.

The local EFSP board comprises members from Abilene Hope Haven, the American Red Cross, 2-1-1 Texas A Call for Help, First Central Presbyterian church, local government officials, and the City of Abilene.

FIRST RESPONDER EMERGENCY & DISASTER ASSISTANCE - \$2,199

In collaboration with the Abilene Police and Fire Departments, United Way's First Responder Emergency and Disaster Assistance (FREDA) Program provides a comprehensive and efficient process to address financial needs when first reponders encounter persons with emergency needs. This relief comes in the form of funds for food, gasoline, or lodging during hours that no community-based basic needs program is available or during the event of a fire or natural disaster.

In 2021, the FREDA program assisted 45 different individuals or families. Historically, FREDA sponsors have included Holy Family Catholic Church, Oldham Lane Church of Christ, and individual donors.



CATALYST FUNDING - \$50,000

Catalyst Funding is designed to give United Way of Abilene the ability to make responsive investments to strengthen systems and networks that support individuals in our area. These investments were possible through gifts made in honor of Mr. Mike Dunnahoo, 2021 Volunteer Service Award recipient.

In its third year, Winter Lightfest has become a staple for family fun during the holidays.





Fundraising Revenue: United Way of Abilene raises funds through workplace and individual giving, corporate and foundation giving, and through local, state, and federal grants.




